Fine Schedule

Pursuant to K.S.A. 12-4305, the attached fines schedule has been established. Fines listed are within the minimum and maximum allowable fines established by ordinance for such offenses by the governing body.

Defective Equipment Violations: If repairs are made and approved by an officer from the Police Department within 72 hours of the violation date, provide proof of repair to the Municipal Court Clerk's office prior to your first scheduled appearance and the charge will be dismissed.

Expired Tag Parking Violations: If tags were renewed prior to the date of the violation, provide proof to the Municipal Court Clerk's office prior to the court date listed on the ticket and the charge will be dismissed.

No Insurance Violations: If insurance was valid on the date and time of the violation, provide proof of current insurance to the Municipal Court Clerk's office within 10 days of receiving the citation. The insurance proof will be submitted to the State Department of Motor Vehicles and placed on a 60-day stay. If insurance is not returned to the Court as invalid, the charge will be dismissed.

Fines assessed on amended charges could be increased pursuant to Prosecutor amendment policies. Requests for amendments to traffic violations should be directed to the City Prosecutor's office at 785-832-6195.

If a defendant fails to appear in court and/or pay fines for traffic violations, a 30-day notice will be issued, pursuant to K.S.A. 8-2110 and amendments thereto. Upon mailing of the 30-day notice, a \$5.00 fee will be assessed. A bench warrant could also be issued at the discretion of the Judge.

Failure to appear in court and/or pay fines for traffic violations prior to the 30-day notice deadline may result in a driver's license suspension, a bench warrant, or both. If a driver's license suspension is issued, a reinstatement fee of \$122.00 per charge will be assessed.

Adjudicated fines that remain unpaid may be submitted to a collection agency and/or the Tax Set-Off Program. An administrative fee of 25% of the total amount due will be assessed on all cases submitted.

If you need additional time to pay your fines, or if you would like to discuss payment options, please appear in court on your regularly scheduled court date and time. You may also be added to the court docket on any weekday when court is in session between 8:00am and 8:30am.

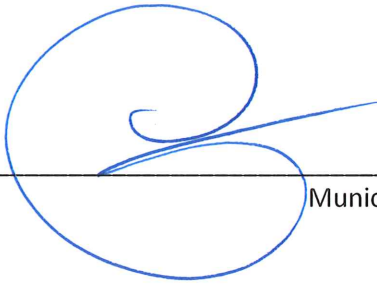
